



## **Terms and Conditions for “Refer your friends to sign up for BOSS!” Promotion**

The Refer your friends to sign up for BOSS Promotion (the “**Promotion**”) is organized by MatchMove Pay Pte Ltd (“**MatchMove**”) and subject to these Terms and Conditions. By participating in the Promotion, all participants shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and all decisions of MatchMove, which shall be final and binding in all respects.

### **1. Eligibility**

- 1.1 This Promotion is valid from 30 January 2018 00:00 to 30 March 2018 23:59.
- 1.2 This Promotion is open to all existing and registered BOSS Mobile Money users aged 18 years and/or over.
- 1.3 All customers who have signed up and completed face-to-face verification are qualified to be part of this Promotion.

### **2. Definitions**

- 2.1 In these Terms and Conditions, the following words and expressions shall have the following meaning:
  - a) “**Referrer**” - an existing BOSS user who has referred a friend to register for a new BOSS account under this Promotion.
  - b) “**Referred Friend(s)**” - a person invited by a Referrer through the BOSS Mobile Money application to register for a new BOSS account under this Promotion.
  - c) “**Referral Incentive**” – incentive corresponding to Referral Points as set out in Section 3.5 below.
  - d) “**Referral Points**” – points forming part of this Promotion that can be used to obtain and/or accumulated to receive desired Referral Incentive subject to the Terms and Conditions contained herein.

### **3. Referral Points & Reward Redemptions**

- 3.1 A Referrer may invite any number of Referred Friends through the BOSS Mobile Money application to register for a new BOSS account under the Promotion.
- 3.2 A Referrer must use the referral form located on BOSS Mobile Money website: <http://www.bossmobilemoney.com/promotions.html> or on the description post of the Promotion on <https://www.facebook.com/BOSSMobileMoney/>.
- 3.3 A Referrer must fully complete the referral form with accurate information.
- 3.4 A Referrer earns **one (1) Referral Point for each new Referred Friend** who has successfully signed up and have completed face-to-face verification at MatchMove, Far

East Plaza #02-50B (Above KFC) and/or at any roadshows location (if any), starting from the start date to the end date of the “**Refer your friends to sign up for BOSS!**” **Campaign**. Each new Referred Friend can only be referred once. Any duplications will be deemed invalid. If the same person is referred by more than one Referrers, the Referrer whose link the Referred Friend uses will earn one (1) Referral Point.

3.5 A Referrer shall be entitled to receive the following referral incentives (“**Referral Incentive(s)**”) depending on the accumulated number for Referral Points for each successful referral, referred by him/her who signed up and have completed face-to-face verification at **MatchMove, Far East Plaza #02-50B (Above KFC) and/or at any roadshows location (if any)**.

3.6 The Referral Points/ Referral Incentives are non-transferable, non-assignable, non-exchangeable and non-redeemable for cash.

3.7 All Referral Incentives are subjected to availability and may be withdrawn or substituted at any time.

3.8 To request for a Referral Incentive, you must have referred the specific number of Referred Friends. You can request for a Referral Incentive at any time, and your Referral Points will be adjusted accordingly.

#### **4. General**

4.1 This Promotion is not open to employees of MatchMove and MatchMove reserves the right to disqualify any participant who fails to comply with any of these Terms and Conditions at its sole discretion.

4.2 These Terms and Conditions are to be read in conjunction with our Customer Terms and Conditions (“**Other Terms**”) available on <https://www.bossmobilemoney.com/terms-and-conditions.html>. In the event of any inconsistency between these Terms and Conditions and the Other Terms, these Terms and Conditions prevail only to the extent of such inconsistency.

4.3 MatchMove reserves the rights to alter, modify and remove any of the Referral Incentives at any time and without prior notice and without assigning any reason. In the event any redeemed Referral Incentives cannot be fulfilled, MatchMove will substitute them with reward item of equal value. The Promotion shall not be valid, wherever it is prohibited by law.

- 4.4 By accepting the referral incentives, the eligible participant agrees that MatchMove may use the eligible participant's personal details, photographs or any likeness for advertising and promotional purposes without further consideration. However, MatchMove is under no obligation whatsoever to disclose the identity of the participant or to publish the same for any reason at any point of time.
- 4.5 MatchMove will verify your residential address and personal details in order to confirm your identity. You agree and allow MatchMove to use your details for sending marketing messages so as you do not miss out any benefit or important information about MatchMove. All information provided by you will be treated securely and strictly in accordance with the Personal Data Protection Act 2012.
- 4.6 This agreement is governed by, and will be construed in accordance with the laws of Singapore. If there is any dispute in connection with this Agreement, the Parties will resolve the dispute through negotiation and conciliation. In case the negotiation and conciliation are not successful, the dispute shall be referred by either Party and finally settled by the Singapore International Arbitration Centre in Singapore. The arbitration panel shall include three arbitrators to be appointed in accordance with the Arbitration Rules of the Singapore International Arbitration Centre ('SIAC'). The arbitration shall take place in Singapore and the language of the arbitration shall be English.
- 4.7 To the maximum extent permitted by law, aggregate liability of MatchMove for any loss or cause of action however arising is limited to SGD 100.
