

## Terms and Conditions for “10 Gifts of Christmas” Promotion

The 10 gifts of Christmas promotion for BOSS Mobile Money (the “**Promotion**”) is organized by MatchMove Pay Pte Ltd (“**MatchMove**”) and subject to these Terms and Conditions. By participating in the Promotion, all participants shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and all decisions of MatchMove, which shall be final and binding in all respects.

### **1. Eligibility**

- 1.1 This Promotion is valid from **1 December 2018 00:00 to 31 December 2018 23:59** (“**Promotion Period**”).
- 1.2 This Promotion is open to all existing and registered BOSS Mobile Money users aged 18 years and/or over.
- 1.3 All customers who have signed up and completed identity verification are qualified to be part of this Promotion.
- 1.4 To be eligible to the Promotion, the participant must hold a valid BOSS Mobile Money account, which said account must be and remain valid and must not for any reasons be terminated and/or suspended, during the Promotion Period.
- 1.5 Notwithstanding anything herein contained, the eligible participants’ BOSS Mobile Money account can only hold, in aggregate, a maximum amount of \$1000.00 (or such other amount as MatchMove may determine in its discretion from time to time) at any point in time. MatchMove shall not be required to credit the Reward or any part thereof to the eligible participants’ BOSS Mobile Money account in excess of such limit. The Reward, or any part thereof that is not credited for such reason shall be forfeited at the sole and absolute discretion of MatchMove, and the eligible participant shall not be entitled to any compensation for the same.
- 1.6 This Promotion cannot be used in conjunction with other promotions, vouchers or other promotional discounts.
- 1.7 Any cancellation on the transaction processed will nullify the participation and you will not be eligible for this Promotion.
- 1.8 MatchMove reserves the right to disqualify any one of more of the eligible participants, if
  - a. participants are determined, in MatchMove’s sole discretion, to be ineligible for any reason whatsoever,
  - b. at any time, MatchMove, at its sole and absolute discretion, suspects any fraud in relation to, and/or misuse of, the eligible participants’ BOSS Mobile Money account; or
  - c. the phone number which is registered in respect of the eligible participants’ BOSS Mobile Money account is for any reason changed (whether by the participant or any other person, with or without the consent or knowledge of the participants) during the Promotion Period.

### **2. Promotion Mechanics**

- 2.1 Users are entitled to one entry for every **successful transaction** and are automatically enrolled into the Promotion. Multiple transactions are permitted.

2.2 The 10 gifts of Christmas will be rewarded to the top 10 remitters and that will be determined based on the total transaction amount (including transfer fees) within the Promotion Period. In the event there are more than one winner, the date, time and number of the transactions will be used as a judging criterion.

2.3 The promotion rewards (the “**Reward**”) are as follows:

2.4 The Reward is strictly non-transferable and non-assignable.

2.5 The qualified eligible participant will be notified via WhatsApp or SMS to their mobile number registered with BOSS Mobile Money and/or in writing by ordinary post (“**Notification**”) within **7 working days following to the end of the Promotion Period** with instructions on further action required to claim Reward.

2.6 Prior to Reward, MatchMove may ask for more details from the participant(s) as per its internal policies or compliance of laws. Reward and/or all the benefits from the Promotion shall be subjected to submission of such details.

2.7 The Reward is strictly NOT exchangeable for any form of cash. Users who closed their accounts after participating in the Promotion will have their unused Reward forfeited.

2.8 All Rewards which are not won or remain unclaimed after two (2) months of the Notification will be forfeited.

2.9 All taxes on benefits from the Promotion shall be borne by the participants.

### **3. General**

3.1 This Promotion is not open to employees of MatchMove and MatchMove reserves the right to disqualify any participant who fails to comply with any of these Terms and Conditions at its sole discretion.

3.2 These Terms and Conditions are to be read in conjunction with our Customer Terms and Conditions (“**Other Terms**”) available on <https://www.bossmobilemoney.com/terms-and-conditions.html>. In the event of any inconsistency between these Terms and Conditions and the Other Terms, these Terms and Conditions prevail only to the extent of such inconsistency.

3.3 Participants shall not, without the prior written approval of MatchMove, speak to the press or any other media nor give any interviews or comments relating to this Promotion.

- 3.4 MatchMove reserves the rights to alter, modify and remove any Reward at any time and without prior notice and without assigning any reason. The Promotion shall not be valid, wherever it is prohibited by law.
- 3.5 MatchMove reserves the sole and absolute right to disqualify any user deemed ineligible for the Promotion (be it under these Terms & Conditions or has engaged in a conduct that MatchMove considers inappropriate or unacceptable).
- 3.6 By accepting the Reward, the eligible participant agrees that MatchMove may use the eligible participant's personal details, photographs or any likeness for advertising and promotional purposes without further consideration. However, MatchMove is under no obligation whatsoever to disclose the identity of the participant or to publish the same for any reason at any point of time.
- 3.7 MatchMove will verify your residential address and personal details in order to confirm your identity. You agree and allow MatchMove to use your details for sending marketing messages so as you do not miss out any benefit or important information about MatchMove. All information provided by you will be treated securely and strictly in accordance with the Personal Data Protection Act 2012.
- 3.8 This agreement is governed by, and will be construed in accordance with the laws of Singapore. If there is any dispute in connection with this Agreement, the Parties will resolve the dispute through negotiation and conciliation. In case the negotiation and conciliation are not successful, the dispute shall be referred by either Party and finally settled by the Singapore International Arbitration Centre in Singapore. The arbitration panel shall include three arbitrators to be appointed in accordance with the Arbitration Rules of the Singapore International Arbitration Centre ('SIAC'). The arbitration shall take place in Singapore and the language of the arbitration shall be English.
- 3.9 To the maximum extent permitted by law, aggregate liability of MatchMove for any loss or cause of action however arising is limited to SGD 100.
